VI. Superintendent's Report

- Mrs. Gadaleta reported that the new district website had been launched. Mrs. Gadaleta stated she is very pleased with the setup as she tested many different devices to open the site. Mrs. Gadaleta explained the new layout of the site which looks more updated and has links to the PTA & Foundation. Mrs. Drogin stated she liked the new look of the site and the Board discussed the use of the site with different applications and devices. Mrs. Gadaleta informed the Board that she requires the staff to update their pages once a month.
- Mrs. Gadaleta reported to the Board the new IPads had arrived and had been distributed. The district will offer the older units to the staff for \$60 to reimburse the PTA and possibly schools in need of IPads. Mrs. Gadaleta asked the Board if it might be a good idea to keep some of the older units for the Pre K and K grades. The Board agreed this was a good idea.
- Mrs. Gadaleta reported to the Board that Title 1 Funds were used to train 8 new teachers. The staff has started utilizing the Wilson tools and has begun lessons with the children. A Wilson trainer will observe the staff and provide feedback.
- Mrs. Gadaleta reported that the Back to School Night was a great success, as only a few families were unable to attend. Mrs. Gadaleta noted that at times parents in the lower grades try to utilize Back to School Night as a time for parent/teacher conferences, which could be difficult for the staff as they are just learning the children. Mrs. Gadaleta suggested to the Board that perhaps back to School Night could be held closer to the first day of school to help alleviate some of the staff stress. The Board felt that would be a good idea. Mrs. Gadaleta noted she would need to discuss with the EFTA before making any decision.
- Mrs. Gadaleta informed the Board that she will be meeting with the Superintendent consortium to discuss the 2017-18 School Year calendar. West Essex is preparing to begin in August, which

- will bring up the issue of the 2015-16 calendar hearing. Mrs. Gadaleta also noted the Superintendent's will discuss the results of the book club they have started.
- Mrs. Gadaleta discussed with the Board the 9/11 Museum Trip. Mrs. Gadaleta said the trip was highly successful, however it was a difficult decision with the events that had taken place over the weekend in New York and New Jersey prior to the trip. Mrs. Gadaleta noted that 4 families pulled out of the trip, but she still felt it was a good decision to go. Mrs. D'Alessandro asked about the traffic into the city, and Mrs. Gadaleta reported there were no issues.
- Mrs. Drogin asked if Mrs. Gadaleta could explain Superintendent's resolutions #3 & 4. Mrs.
 Gadaleta responded that they are part of the Mandated Memorandum of Assurance. Mrs.
 Gadaleta briefly explained the anti-bullying self-assessment which she reviewed with Mrs.
 Codella. Mrs. Gadaleta then noted that resolution #4 really does not directly affect EFS and we are stating we are in compliance of not forcing anyone to pray while in school.

They informed us they have not hired a replacement but feel they are getting close. Mrs. Gadaleta also noted that she will be advertising for the open paraprofessional position and hopes to fill it as soon as possible.

XI. New Business / Board Discussion

- Mrs. Gadaleta informed the Board that the Art Club paints a mural each year in the school and this year they would be painting the hallway outside of the Superintendent's Office. Mrs. Gadaleta stated that Mr. Trogani and Mrs. McNish were very excited. Mrs. Gadaleta asked the Board if they were ok with upgrading the murals that were over 10 years old. The Board agreed that this might not be a bad idea as we are not going to be able to restore them. The Board agreed that a picture should be taken of the murals as they are replaced.
- Mrs. Gadaleta updated the Board as to an injury that had taken place last night after school hours on the pre-school playground. Mrs. Gadaleta noted that a former student was playing on the playground and fell breaking the fence and his arm. Mrs. Gadaleta informed the Board that the fence is relatively new and is in good shape. The district will repair the broken fence and the Board hoped that the child was ok.

- 5. Nurturing a love of country and a pride in our American heritage and citizenship.
- 6. Communicating a love of scholarship and continued interest in life-long learning.
- 7. Insuring all pupils will achieve the New Jersey Core Curriculum Content Standards at all levels.

To secure these common goals, the Essex Fells staff of professional educators recognizes that the collaborative engagement of the children in the learning process is the key to intellectual development. Dedicated teachers create classrooms that are alive with cooperative learning activities and child-centered problem solving routines. Children are encouraged to explore, to question, to make decisions, and to express opinions in a supportive learning environment. Ongoing professional development is acknowledged as the foundation for promoting outstanding pupil achievement.
