## V. Buildings Grounds

• Mr. Lella provided the Board with an updated timeline for the AC installation project. The drawings were dropped off yesterday to the Borough for review. March 20th the documents will be available for the bidders to pick up at the architect's office. March 22th will be the walk thru. Bids will be read April 18th.

- Mrs. Gadaleta informed the Board the Science, Language Arts & Math curriculums are all going through

- Mrs. Gadaleta informed the Board of an unanticipated home instruction. The district is working with the
  family and the doctor to set a start state. There will be a 30-day segment followed by a re-evaluation.

  instruction
- Mrs. Gadaleta reported to the Board we will be celebrating Read Across America this week, with author Wendy Mass coming in on Friday to speak to the students.
- Mrs. Gadaleta publicly thanked Mrs. Tedesco for a great day for the mock trial. Mrs. Gadaleta was very appreciative of Mrs. Tedesco and Mayor Abbott for their involvement.

- Mr. Lella reviewed the 2017-18 Budget with the Board and the release of State Aid.
- Mr. Lella updated the Board on the recent Essex County School Board Association School Funding Meeting he attended. Districts voiced their concerns regarding being underfunded and dealing with rising costs not limited to a two percent cap such as Out of District Tuition & Transportation, charter school tuition and insurance costs.

  appropriate.

- Mrs. Gadaleta informed the Board that their packages included the QSAC Equivalency Approval letter.

- Mrs. Gadaleta suggested to the Board combining the April meetings due to the spring break. The Board agreed to cancel the April 5<sup>th</sup> meeting.
- Mrs. Gadaleta informed the Board that the annual appointments meeting for the 2017-18 school year would be at the May 31<sup>st</sup> meeting rather than in June.
- The Board discussed potential dates for snow day givebacks. The Board agreed with the Monday after Easter Sunday and the Friday before Memorial Day Weekend. The dates are subject to change in the event of another snow day, with the Friday before Memorial Day as the day that would be removed.
- Mrs. Gadaleta asked the Board if they would be ok with allowing the rec program to use the electric scoreboard in the gymnasium. The Board was ok with this request.
- Mrs. Gadaleta informed the Board that the National Blue Ribbon Sign had been installed on the sign
  outside of the gymnasium.
- Mrs. Gadaleta informed the Board that Mrs. Sarto was working hard to update the Essex Fells job
  descriptions and she hopes to have them re-adopted at a future meeting.
